## NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION

## **PROJECT OVERVIEW**

The applicant, Clean Harbors Environmental Services, Inc., requests a CUP to authorize the change of use of an existing 33,465 square feet storage and distribution warehouse with outdoor storage to a storage and distribution warehouse with outdoor storage and the storage of hazardous materials ("Project"). The Project does not propose any changes to the square footage of the existing warehouse, but there are proposed interior and exterior tenant improvements. Interior improvements include installing high-piled storage racks, constructing a storage room for flammable liquids storage, upgrading the fire suppression system, and adding employee locker rooms. Exterior improvements include bringing the accessible parking space and path of travel to the building entrance into compliance with the current building codes, adding landscaping, and placing a fire rated storage container at the south easternmost edge of the exterior yard area. The existing warehouse was established through Plot Plan 25993 on February 22, 1973. Subsequently, Site Plan Review RPPL2019006827, approved on February 5, 2020, authorized the continued operation of the warehouse with the incidental use of outdoor storage of trucks, vehicles, and equipment supporting the business operations. Pursuant to the Los Angeles County Code Section 22.22.030-D.3., a CUP is required for the storage of hazardous materials.
