NOTICE OF INTENT TO ADOPT A RECIRCULATED INITIAL STUDY/MITIGATED NEGATIVE DECLARATION

The City of Rancho Cucamonga has prepared this Notice of Intent to adopt a recirculated Mitigated Negative Declaration for the project listed below. A previous Initial Study/Mitigated Negative Declaration for the proposed project was circulated for a 30-day public review period beginning on September 1, 2021, through September 30, 2021. As the CEQA Lead Agency, the City of Rancho Cucamonga is recirculating the Initial Study/Mitigated Negative Declaration (IS/MND) for the proposed project to clarify changes that have arisen during or since the public review period. These changes are identified in the Recirculated IS/MND.

Based upon the conclusions set forth in the Recirculated IS/MND, the City of Rancho Cucamonga finds that the proposed Project, with mitigations measures and conditions of approval designed to minimize environmental impacts, will not result in significant adverse effects on the environment. The project will also provide 528 parking spaces for residents, guests, and commercial visitors within a subterranean parking garage and using surface parking.
