Project Location (Marin County): The project is located at three unnamed tributaries to Basalt Creek at 8161 Redwood Boulevard, Novato, CA 94945. The project centroid is approximately Latitude 38.13350°N, Longitude 122.56620°W

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-MAN-15643-R3), pursuant to Fish and Game Code section 1602, to the project Applicant, Habitat for Humanity Greater San Francisco, Inc.

The project is limited to filling portions of the three unnamed tributaries at the site, constructing a new stream channel, and installing a pedestrian bridge.
