PROJECT TITLE: Drought Resiliency of Mt. Diablo Manzanita and Knobcone Pine Forests

LOCATION: Mount Diablo State Park

COUNTY: Contra Costa

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Reduce the fuel buildup from dead material and over-crowded conditions along roads and trails in Mount Diablo State Park to reduce risk of high intensity wildfire and prepare the sites for potential prescribed burns in future project phases which is essential for promoting regeneration of healthy manzanita and pine populations. This project will start Winter 2021 and is expected to be ongoing for two (2) years. Work will:

- Use District Staff, youth corps crew, and/or contractor crews to remove standing fuel resulting from manzanita and pine die-back along portions of Knobcone Point Road, Black Hawk Ridge Road, Wall Point Road, Summit Trail Road, and Summit Road;
- Thin approx. 50% of live plants and remove all dead and symptomatic material within a 100' buffer of the roads that surround known mortality areas (approx.160 acres);
- Thin an additional 210 acres, within the potential burn areas, of 50% of ladder fuels;
- Develop experimental thinning plots to evaluate the effectiveness of removing dead and symptomatic material to reduce the spread of pathogens and the feasibility of large-scale manual management. Plot numbers, size, and locations are yet to be determined but all vegetation removal across all plots will equal less than one acre;
- Dispose of all removed material via trailer mounted curtain burner or chip and transport to a landfill to reduce potential for spread of pathogens;
- Develop a prescribed fire plan for approximately 450 acres along Wall Point and Knobcone Point. Use existing roads and trails as a natural fire break and establish additional control lines reflective of previous burns; and
- Have District Staff collect seeds from knobcone pines for long-term storage and take 100 cuttings each from Mt. Diablo and Contra Costa manzanita for propagation in a native plant nursery.
