NOTICE OF AVAILABILITY OF PUBLIC DRAFT PROGRAMMATIC ENVIRONMENTAL IMPACT REPORT NOTICE OF PUBLIC MEETING

NOTICE IS HEREBY GIVEN that a Public Draft Programmatic Environmental Impact Report (PEIR) has been prepared and is available for public and agency review and comment.

LEAD AGENCY: Las Virgenes – Triunfo Joint Powers Authority **PROJECT NAME:** Pure Water Project Las Virgenes-Triunfo

PROJECT LOCATION: The Pure Water Project Las Virgenes-Triunfo (Pure Water Project) is in the northwestern portion of the greater Los Angeles region, within portions of the cities of Agoura Hills, Westlake Village, Thousand Oaks, and unincorporated Ventura County.

PROJECT DESCRIPTION: Las Virgenes - Triunfo Joint Powers Authority (JPA), a partnership of Las Virgenes Municipal Water District and Triunfo Water & Sanitation District, proposes a series of projects that will process surplus recycled water, currently discharged to Malibu Creek from the Tapia Water Reclamation Facility, through an advanced treatment facility and store it at Las Virgenes Reservoir for later use as drinking water - collectively, the Pure Water Project Las Virgenes-Triunfo. The Pure Water Project will include a new advanced water purification facility (AWPF) to treat recycled water for indirect potable reuse and convey the purified water to the existing Las Virgenes Reservoir, which will act as an environmental buffer, and where it will be blended with the existing drinking water supplies. The water will then be treated at the Westlake Filtration Plant prior to being distributed to customers. Pipeline construction will be required to extend the existing recycled water system to the AWPF, convey purified water from the AWPF to Las Virgenes Reservoir, and convey the "reject" waste stream (concentrate) from the AWPF to the Calleguas Salinity Management Pipeline. While a portion of the concentrate pipeline will be constructed in the streets of Agoura Hills and Westlake Village, most of it will extend outside of the JPA's jurisdiction and through the City of Thousand Oaks and unincorporated portions of Ventura County. A complete Project Description is available in Chapter 2 of the PEIR.

ENVIRONMENTAL IMPACTS: In accordance with the California Environmental Quality Act (CEQA), the PEIR identifies and discusses the potential environmental impacts of the project. The potential for significant impacts is analyzed for the following: aesthetics, air quality, biological resources, cultural and paleontological resources, energy, geology and soils, greenhouse gases, hazardous materials, hydrology and water quality, land use, noise, recreation, transportation and traffic, tribal cultural resources, and wildfires. The PEIR also proposes mitigation measures to be incorporated in the project that would reduce the impacts, where possible, to less than significant levels.

The PEIR concludes that the project would potentially result in significant and unavoidable impacts to special-status plants and to recreation resources, even with proposed mitigation to reduce impacts. All other potential impacts would be less than significant or reduced to a less than significant level with proposed mitigation measures. The project site is not included on the State's Hazardous Waste & Substances Sites list.
