Description of Nature, Purpose, and Beneficiaries of Project:

The purpose of the project is to stabilize the bank of the Sacramento River on the property to prevent further erosion and loss of property. The project includes the placement of rock slope protection (RSP) along the bank of the Sacramento River. Prior to the placement of RSP, portions of the bank will be excavated to form a slope of 0.75:1. Soil will be excavated, RSP fabric will be placed, and RSP will be installed approximately 3.3 feet thick. The project will not include the removal of any mature, healthy trees. An excavator will be used to excavate material from the bank of the Sacramento River as well as to place the RSP. The excavator will be operated at the top of the bank of the river. Work will be completed during periods of low water in the Sacramento River when the work area is naturally dewatered.
