Project Description (Proposed actions, location, and/or consequences).

Request to expand the area of an existing private school from 5± acres to 7± acres by incorporating a 2± acre area for a track and soccer field in the A-2-40 zoning district. This use permit will amend the boundaries for the school located on APN 005-030-035 and permit the proposed track and field currently located on APN 005-030-020. No construction or site development is proposed. The existing track is 24-feet wide, composed of hard packed dirt and encircles a 1.3± acre field. The existing field receives irrigation water from Modesto Irrigation District. The applicant requests an alternative from the County's Agricultural Buffer requirements on the east and north portion of the project site. The project site is developed with 26,000± square-feet of instructional building space, two dwellings occupied by facility caretakers, and accessory buildings. The school operates Mon-Friday from 8:00 a.m. to 3:00 p.m. No public use of the track is proposed. The school enrolls 60-85 students from Kindergarten to 8th grade and 27 employees. Students are brought to school by 6-7 buses and 10 individual vehicles. No increase in the number of students/employees is anticipated. The site is served by an existing Public Water System and private septic system, and has access to County-maintained Finney Road.
