Project Description (Proposed actions, location, and/or consequences).

Request to expand the area of an existing private school facility from 5± acres to 7± acres by incorporating a 2± acre area for a track and soccer field in the A-2-40 zoning district. This use permit will amend the boundaries for the school located on Assessor Parcel Number (APN) 005-030-035 and permit the proposed track and field currently located on the eastern portion of APN 005-030-020, to the north of the school facility. If approved, a Lot Line Adjustment (LLA) application will be processed to maintain the use on one parcel. No construction or site development is proposed under this request. The proposed track is currently 24-feet wide, composed of hard packed dirt and encircles a 1.3± acre field. The applicant has requested an alternative from the County's Agricultural Buffer requirements. The project site is currently developed with 26,000± square-feet of building space, two residences, a tool shed and a 3,575± square-foot barn. The school operates Monday through Friday from 8:00 a.m. to 3:00 p.m. No public use of the track is proposed. The school currently enrolls 60-85 students and a total of 27 employees. No increase of students or employees is anticipated. The site is served by private well and septic system and has access to County-maintained Finney Road.
