DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Project will complete repairs at the the Historic Fallon Theatre located inside Columbia State Historic Park to protect and preserve the historic building, protect public health, and improve the visitor experience. Work will;

- Replace the eight (8) fixed panel windows in kind with TM Cobb wood single glazed 4 pane sashes.
- Replace window casing, trims, and sills with in kind with full dimension rough sawn cedar 1"x4" window trim, 2"x4" uprights, and 2"x10" windowsills;
- Use Fortiflash window flashing and exterior grade clear silicone to seal the windows, and window trims against water infiltration; and,
- Outside of the Fallon Theatre, replace in kind the full dimension 4"x6" posts, and the 2"x4" horizontals of the wood fence and repair or replace in kind the 1"x12" full dimension rough sawn fence boards.
