Project Title: Waste Management Unit G Reconstruction

Applicant: Yolo County Division of Integrated Waste Management

Project Location: Yolo County Central Landfill, located at 44090 County Road 28H, Woodland, CA 95776 (APN: 042-140-006)

<u>Project Description</u>: The project involves replacement of liquid waste containment features to Waste Management Unit G (WMU-G), a class 2 (double lined) liquid surface impoundment at the Yolo County Central Landfill that was originally constructed in 1995. Wastes received in WMU-G include landfill leachate, septage, portable toilet and other non-hazardous liquid wastes. The primary containment features of the unit are nearing their useful life and must be replaced before failure. Additionally, the containment berms around the unit must be raised to meet flood protection requirements, due to a change in special flood hazard area mapping at the Landfill.


Reconstruction activities consist of demolishing existing concrete, primary and secondary geomembranes, and associated features; extending perimeter berms and compacted clay portion of the containment system; reconstructing the primary and leak detection sumps; reinstalling new primary and secondary geomembranes; installing a new concrete wear surface over the entire unit; and, improving the customer dump locations. Reconstruction will occur within the existing unit footprint and involves a negligible expansion of use.

During reconstruction, a temporary bin system for liquid waste customers will be maintained to ensure uninterrupted customer service.

Exempt Status: The project is categorically exempt from further environmental review based on Sections 15301 and 15302 of the California Environmental Quality Act (CEQA) Guidelines.

<u>Reasons why project is exempt</u>: Section 15301 allows a "Class 1" Categorical Exemption for the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible expansion of use beyond that existing at the time of the lead agency's determination. The project is for repair and maintenance to an existing facility, and involves a negligible increase in capacity of liquid waste containment.

Section 15302 allows a "Class 2" Categorical Exemption for the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced. The project will rehabilitate Waste Management Unit G at the Yolo County Central Landfill to replace aging containment



features before they fail. Reconstruction of the unit will not result in a significant expansion or increase in capacity.
