

## NOTICE OF AVAILABILITY (NOA) OF A DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE 2023-2031 DANVILLE HOUSING ELEMENT, PUBLIC COMMENT PERIOD AND PUBLIC HEARING TO ALLOW PUBLIC COMMENTS ON THE DRAFT ENVIRONEMNTAL IMPACT REPOR

**Project Description:** The Housing Element is a state-mandated policy document that is a component of the Town of Danville 2030 General Plan. The Housing Element contain policies and programs that support and create the framework for the production, preservation, and maintenance of the Town's housing stock for all income levels.

**Project Location:** The Project encompasses all land within the Town of Danville (approximately 11,600 acres) and an additional approximately 325 acres in unincorporated Contra Costa County located within the Danville Sphere of Influence.

**Significant Impacts:** The Draft EIR concluded that the Housing Element Update will have potentially significant environmental effects on Greenhouse Gas Emissions, Transportation, and Utilities and Service Systems.

**Hazardous Materials:** Six of the candidate housing sites are included on a list of hazardous materials sites compiled pursuant to California Government Code Section 65962.5 (Cortese List). Five of the listed sites are shown as closed cases.<sup>1</sup> 514 San Ramon Valley Boulevard (APN 216101001) in Sub Area 2 is identified as an open cleanup site with residual dry-cleaning solvents in the soil.
