PROJECT TITLE: Camp KEEP Waterline Project

LOCATION: Montaña de Oro State Park **COUNTY:** San Luis Obispo County

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: The project will replace leaking water tanks, lines, and fire hydrants at Camp KEEP in Montaña de Oro State Park in order to provide potable water for park visitors and adequate water supplies for fire suppression purposes. Work will:

- Replace two (2) 8,000-gallon redwood tanks with similarly sized steel tanks placed on graded gravel and concrete pads;
- Within the lens of the roadway, excavate a trench 18-inches deep to:
 - Install a 2,150 foot long 4-inch main water line and two (2) 1,500 foot long 2-inch water lines for irrigation and supply, and
 - Install a 1,500 foot long 2-inch electrical conduit for future SCADA;
- From the 4-inch main line, install 2-inch lateral lines that end at each building;
- Replace the existing 2-inch fire hydrants with 4-inch hydrants and connect to the main line;
- Install shut-off valves and meters to monitor the system;
- Back-fill trenches and cover with an additional 4 to 6 inches of compacted road base;
- Abandon all existing water lines in place.
