Description of Nature, Purpose and Beneficiaries of Project:

The Central Coast Prescribed Burn Association will carry out 2 training burns on the Santa Lucia Preserve property, covering approximately 116 acres. The prescribed burns will take place during suitable weather conditions in accordance with Burn Plan under the supervision of certified burn boss, Phillip Dye. Site 1 "Lot 5 and Animus 1 Units" is 109 acres of grassland, coastal scrub, and oak woodland on the west side of Rancho San Carlos Road. Site 2 "Kelleher Unit" is 7 acres of brush encroached grasslands on the north side of Rancho San Carlos Road.
