The subject parcel is located on the north side of Dinkey Creek Road, approximately one quarter-mile east of State Route 168/Tollhouse Road, within the unincorporated community of Shaver Lake (APN 120-260-10U) (SUP. DIST. 5) (41694 Dinkey Creek Road).

The subject parcel is designated as Open Space in the Shaver Lake Community Plan.

# 7. Zoning:

RC-40 (Resource Conservation, 40-acre minimum parcel size) Zone District

8. Description of project: (Describe the whole action involved, including, but not limited to, later phases of the project, and any secondary, support, or off-site features necessary for its implementation. Attach additional sheets if necessary.)

Allow the expansion of the existing Southern California Edison, Shaver Lake Service Center laydown yard with the construction of a new gated access road connecting to Dinkey Creek Road. The project will also include the installation of a 1,440 Square-foot mobile office/transmission trailer, within the approximately 2.34-acre laydown yard, on the existing 357.80-acre subject parcel, in the RC-40 (Recreational, 40-acre minimum parcel size) Zone District.

# 9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The subject parcel is located in a mountainous area, adjacent to Shaver Lake. The immediate vicinity of the project site contains a mix of residential and commercial land uses.

Under the provisions of Assembly Bill (AB) 52, the County was required to provide notice of preparation of this Initial Study to Native American tribes who had previously indicated interest in reviewing CEQA projects. Notices were sent on September 13, 2021 to the appropriate Tribal government representatives. None of the Tribes requested consultation on or expressed interest in this project.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code Section 21082.3(c) contains provisions specific to confidentiality.
