631-14. The proposed project site is located near the intersection of Rancho Road and

Koala Road in the southwestern portion of the city.

**DESCRIPTION:** The City of Adelanto is reviewing an application submitted by Mary Ma to develop on a

> 3.03-acre (132,077 square-foot) parcel within the southeastern portion of the City of Adelanto. The proposed project involves the construction of six, two-story cannabis cultivation, distribution, and manufacturing facilities with a total floor area of 97,428 square-feet. In addition, 52 standard parking spaces and 6 ADA compliant stalls will be provided. The property currently has a General Plan and Zoning land use designation of Manufacturing/Industrial (MI). The project site is not located on any known or suspected

hazardous waste site.

The environmental analysis provided in the attached Initial Study indicates that the FINDINGS:

proposed project would not result in any significant adverse unmitigable impacts. For this reason, the City of Adelanto determined that a Mitigated Negative Declaration is the appropriate CEQA document for the proposed project. The following findings may

be made based on the analysis contained in the attached Initial Study:

• The proposed project will not have the potential to substantially degrade the quality of the environment, substantially reduce the habitat of a fish or wildlife species, cause a fish or wildlife population to drop below self-sustaining levels, threaten to eliminate a plant or animal community, substantially reduce the number or restrict the range of a rare or endangered plant or animal or eliminate important examples of the major periods of California history or prehistory.

- The proposed project will not have impacts that are individually limited, but cumulatively considerable.
- The proposed project will not have environmental effects which will cause substantial adverse effects on human beings, either directly or indirectly.




EXHIBIT 1
PROJECT LOCATION IN THE CITY






EXHIBIT 2
VICINITY MAP




