Project Location - Specific: The project site is located on the north side of E. Sedan Ave., 2,720 feet east of S. Main

Project Description: Site Approval application for an unmanned telecommunications facility within a 50 foot by 50 foot fenced site within a 70 foot by 70 foot lease area. Maximum height of the proposed telecommunications tower is 114 feet. The applicant proposes to bring power and Telco utilities to the site from the utility poles located on the Public Right of Way. This parcel is not under a Williamson Act Contract.
