PROJECT DESCRIPTION

The City of Lynwood is proposing improvements along Imperial Highway at Long Beach Boulevard and California Avenue in the City of Lynwood. This improvement is part of the Interstate 710 (I-710) Corridor Improvement Project Early Action Program. In 2008, Measure R was passed for transportation improvements in Los Angeles County. As a part of this measure, \$590 million was set aside for I-710 South and/or Early Action Projects of which \$160 million was allocated to non-freeway improvements. In order to establish and prioritize projects using this funding source, Metro has worked closely with the Gateway Cities Council of Governments (Gateway COG) and the City of Lynwood, with Metro as the acting administrative lead agency. The I-710 Technical Advisory Committee (TAC) has approved the Project and requested Metro to program funding to cover the engineering and environmental phases.

PROJECT IMPROVEMENTS

Proposed intersection improvements at Long Beach Boulevard would include increasing storage lengths for the eastbound and westbound left-turn lanes and the addition of an eastbound right turn lane. The increased storage length for the westbound left-turn movement is provided by proposing an additional left-turn lane. To accommodate the additional westbound left-turn lane, removal of on-street parking has been proposed along Imperial Highway in the westbound direction. Traffic signal heads would also be modified to accommodate for the additional left turn lane. A 2-foot raised median along Imperial Highway is proposed to restrict left turn movements from exiting from the driveway in the southeast corner of the intersection. Continental crosswalks composed of thick vertical striping are proposed to increase visibility for pedestrians. The intersection improvements will include various areas of pavement rehabilitation within the limits of the pavement striping.

Proposed intersection improvements at California Avenue would include increasing storage length for the southbound, eastbound, and westbound left turn lanes. Continental crosswalks composed of thick vertical striping are proposed to reduce pedestrian accidents. The intersection improvements will include various areas of pavement rehabilitation within the limits of the pavement striping. The project would synchronize traffic signals along the Imperial Highway Corridor.

ENVIRONMENTAL REVIEW

The City of Lynwood is the Lead Agency under the California Environmental Quality Act (CEQA). GPA Consulting (GPA), on behalf of the City of Lynwood, conducted a review of environmental resource databases and background documents to characterize the project area, identify potential environmental resources, and determine the level of environmental review required under CEQA. Based on the review, the City of Lynwood determined that the project would not have a significant effect on the environment. The CEQA Guidelines lists classes of projects determined by the State of California to be exempt from the requirements of CEQA because they have no significant effect on the environment. A project is categorically exempt from CEQA if it fits into one or more of these exemption classes and no unusual circumstances exist that would cause the project to have a significant effect on the environment. Based on analysis of the Project, the Project is exempt from CEQA pursuant to CEQA Guidelines, Article 19, Categorical Exemptions, Section 15301, Existing Facilities (Class 1).

WHEREAS, the City received funding from the Los Angeles County Metropolitan Transportation Authority (Metro) in the amount of \$865,000 for the Project Approval and Environmental Document (PA&ED); and Plans, Specifications, and Estimates (PS&E) for the Imperial Highway Corridor Capacity Enhancement Project; and

WHEREAS, on January 19, 2021, the City Council approved to proceed with the "Intersection Improvements Alternative" for the Imperial Highway Corridor Capacity Enhancements Project; and

WHEREAS, Metro has refined the traffic operations analysis and recommends selection of the preferred alternative which is the focused intersection improvements with signal synchronization on Imperial Highway between State Street and Wright Road; and

WHEREAS, GPA Consulting (GPA), on behalf of the City of Lynwood, conducted a review of environmental resource databases and background documents to characterize the project area, identify potential environmental resources, and determine the level of environmental review required under California Environmental Quality Act (CEQA); and

WHEREAS, pursuant to CEQA, Title 14 CCR § 15301. Existing Facilities, provide that minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities are categorically exempt from the provisions of CEQA and thereby will not result in a significant effect on the environment; and

WHEREAS, the grant provided does not cover the costs for City's staff or consultant's time managing this Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNWOOD DOES HEREBY FIND, PROCLAIM, ORDER, AND RESOLVE AS FOLLOWS:

<u>Section 1.</u> That the City Council approve the preferred alternative-focused intersection improvements with signal synchronization on Imperial Highway between State Street and Wright Road.

Section 2. That in compliance with CEQA, the City Council finds that the activity, improvements at the following intersections at Imperial Highway: 1) State Street, 2) Long Beach Boulevard and California Avenue, 3) Bullis Road, 4) Atlantic Avenue, and 5) Wright Road, is exempt under CEQA pursuant to CEQA Guidelines Title 14 CCR § 15301. Existing Facilities.

<u>Section 3.</u> The City Manager or his authorized designee, is hereby directed to file the attached Notices of Exemption with the County Clerk of the County of Los Angeles.

<u>Section 4.</u> That The City Council authorize the request of Measure R Funds at the Gateway Cities Council of Governments I-710 Technical Advisory Committee for final design and construction phases.
