## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

**NOTICE IS HEREBY GIVEN THAT THE BOARD OF SUPERVISORS OF THE COUNTY OF NAPA** on Tuesday, the 1st day of February 2022, at 9:00 a.m. at 1195 Third Street, Suite 305, Napa, California, is considering adoption of a Mitigated Negative Declaration for the project identified below:

## DRY CREEK ROAD BRIDGE REPLACEMENT PROJECT/ RDS 15-22

Napa County Department of Public Works (County), in cooperation with the California Department of Transportation (Caltrans), proposes to replace the existing structurally deficient Dry Creek Road Bridge (bridge) over Dry Creek as a part of the Highway Bridge Replacement and Rehabilitation Program (HBRRP). The bridge (Bridge No. 21C0056) is 0.8 mile west of Mt. Veeder Road and spans over Dry Creek in an unincorporated rural area of Napa County, California within the AW – Agricultural Watershed zoning district. There would be no expansion in the number of travel lanes. The existing bridge and roadway would be removed while maintaining access to the properties along Dry Creek Road and Dry Creek Fork Road. The new bridge would be constructed along a roughly east-west alignment located approximately 150 feet south of the existing bridge in order to straighten the bridge approach and bypass the hairpin curve segment of Dry Creek Road. Adjacent to Assessor's Parcel Numbers 027-330-002, -010, -015, -017, & 027-530-003, -004.

**CEQA STATUS:** Mitigated Negative Declaration Prepared. According to the proposed Mitigated Negative Declaration, the proposed project would have potentially significant environmental impacts on Biological Resources, if mitigation measures are not included. This project site is not on any of the lists of hazardous waste sites enumerated under CA Government Code Section 65962.5.

The proposed Mitigated Negative Declaration application is available for inspection, along with copies of all documents that relate to the above-described project, between the hours of 8:00 AM. and 4:30 PM Monday through Friday, at the office of the Napa County Planning, Building, & Environmental Services and Public Works Departments, 1195 Third Street, Second Floor, Napa, California.
