## Project Description

The Modesto Amtrak Station Second Platform Construction Project (Project) consists of construction of a second passenger platform at the station, and all required associated track, signal, and grade crossing work, as well as potential construction of a pedestrian underpass.

Construction to include, but is not limited to, placement of a 600-foot long cast-in-place platform with passenger appurtenances (e.g. lighting, benches, etc.). Includes construction of a 3,000-foot long station track on the south side of the station with intertrack fencing, modification of the existing road crossing, and construction of a pedestrian overpass or underpass. All work to be performed in compliance with BNSF, CPUC, or Amtrak engineering standards, as applicable. All work to be performed is on existing BNSF right of way.
