NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Project: Digital 299 Broadband Project

Description: Vero Fiber Networks, LLC proposes to install approximately 300 miles of new conduit and fiber optic cables to provide internet to unserved or underserved communities in northern California. The Project route generally follows the State Route 299 corridor through Trinity, Shasta, and Humboldt counties. Conduit would be installed within pre-disturbed road shoulders. The Project also includes the construction of up to five small regeneration buildings (ILA buildings) placed along the route. Some last-mile connections would be attached to utility poles during a second phase of the Project. State and federal agencies have collaborated to leverage a joint Environmental Assessment/Initial Study Mitigated Negative Declaration (EA/ISMND) and associated technical studies to support their separate decisions and permits.

CEQA Status: Consideration and possible adoption of a Mitigated Negative Declaration. According to the Mitigated Negative Declaration, the proposed project would not have any potentially significant environmental impacts after implementation of mitigation measures. Mitigation measures are proposed for the following area: Biological Resources.
