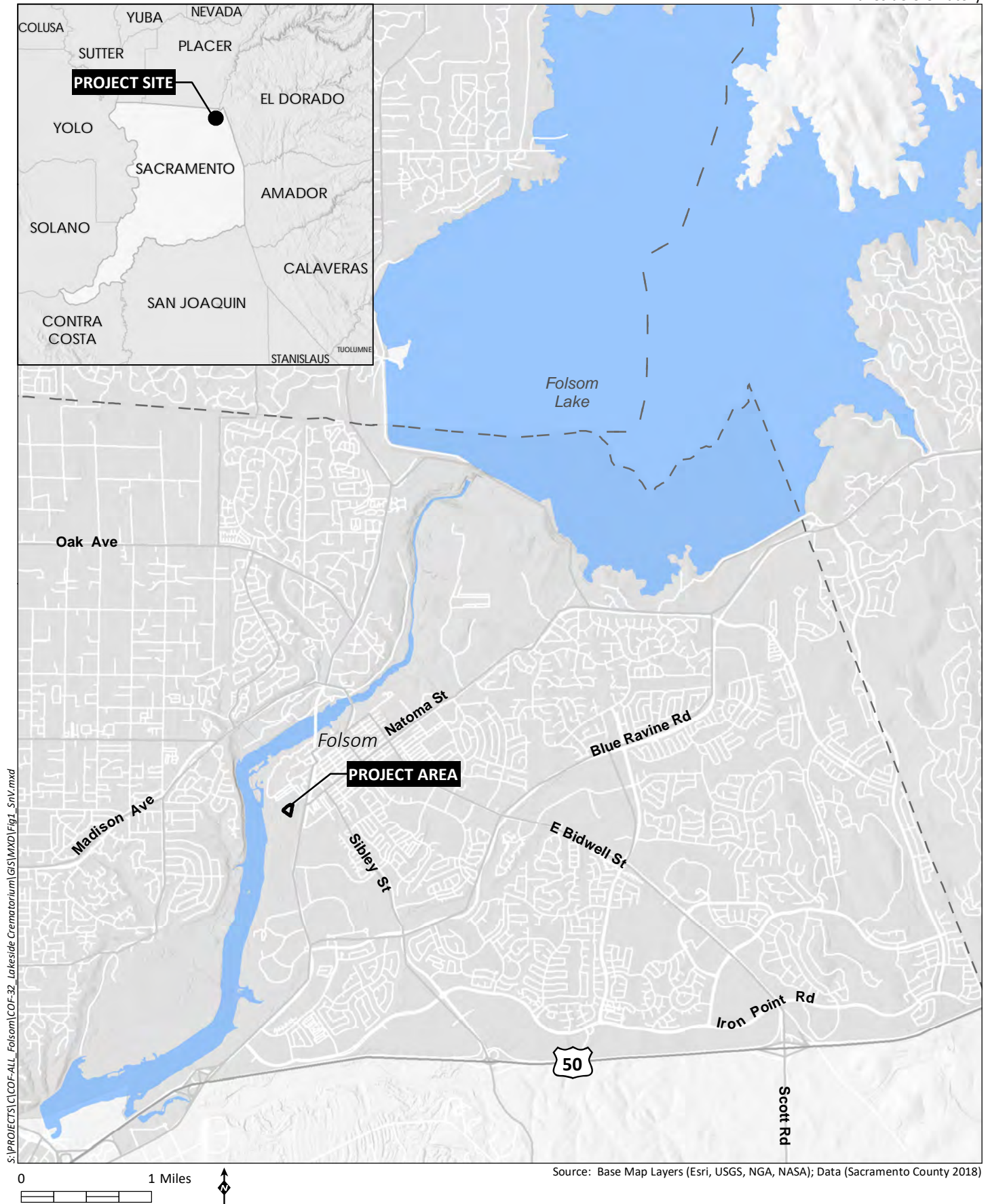

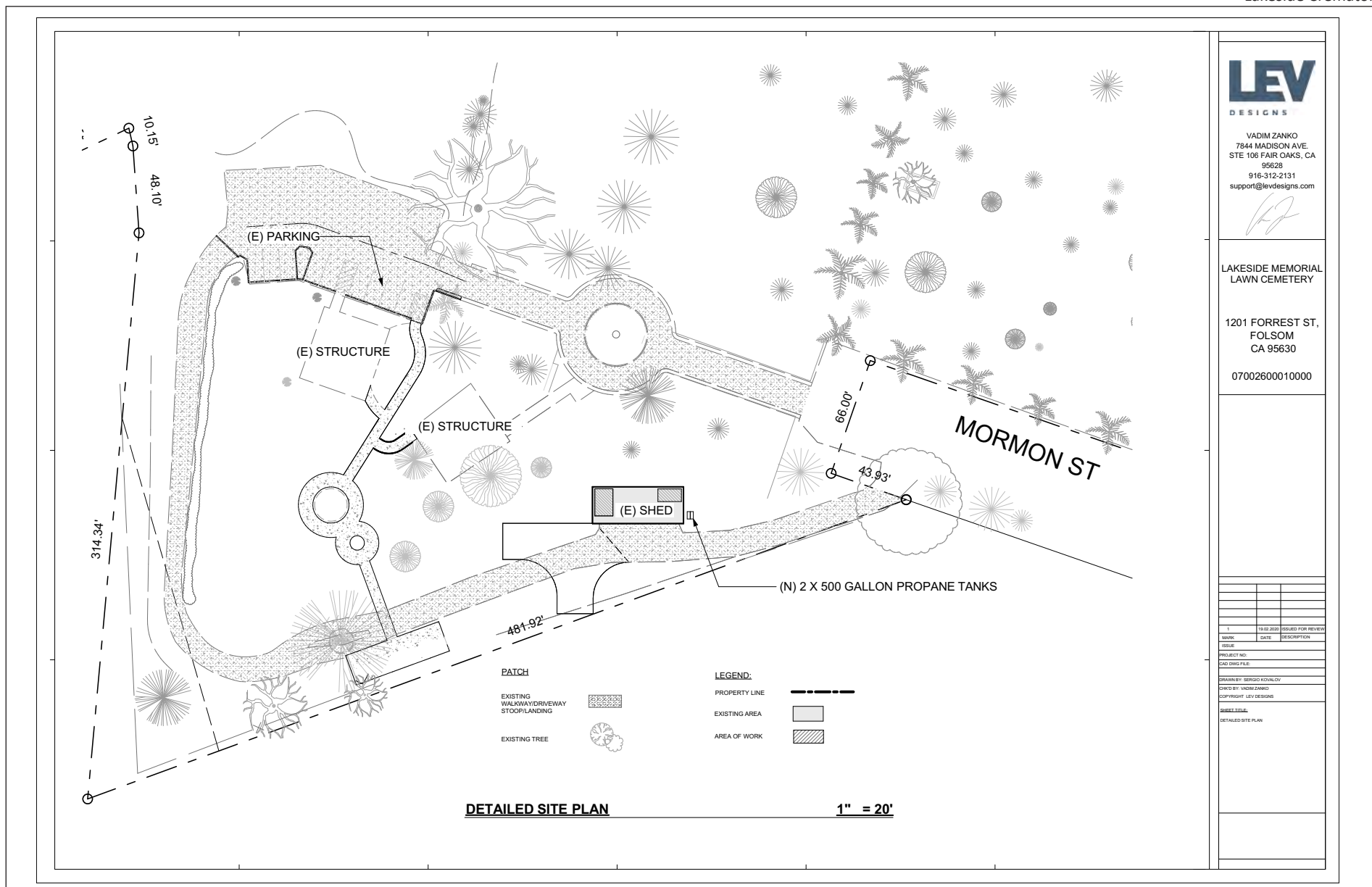

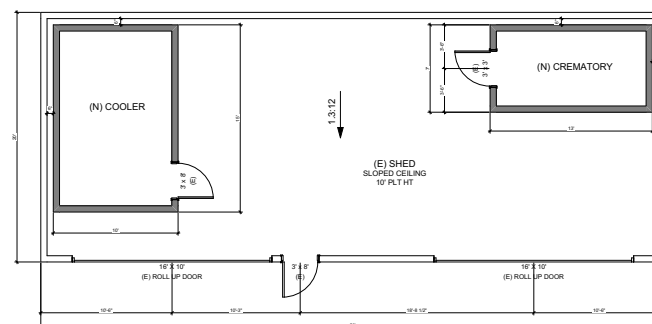

EXISTING FLOOR PLAN

FLOOR PLAN NOTES:

1. WINDOWS AND DOORS NOTED IN FEET (E.G. 30x40-1/2"x14'-0").
2. DOORS ARE NOTED WITHOUT FRAME. CONTRACTOR TO VERIFY WITH MANUFACTURER FOR DOOR FRAME SIZE PRIOR TO FRAMING DOOR OPENINGS.
3. DO NOT SCALE OFF PLANS.
4. ALL DIMENSIONS ARE TO FACE OF STUD U.N.O.
5. WALL INSULATION TO BE A MINIMUM OF R-13 BATTING AND ATTIC INSULATION TO BE R-30 BATTING IN BATT OR RIGID.
6. IN ALL VERIFICATION OF ALL DIMENSIONS AND CONDITIONS SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR AND THE SUB-CONTRACTORS. NOTES DIMENSIONS THAT PRECEDENT OVER SCALE. EACH CONTRACTOR OR SUB-CONTRACTOR SHALL REPORT TO ARCHITECT/DESIGNER ALL CONDITIONS WHICH PREVENT THE PROPER EXECUTION OF THEIR WORK.
7. DESIGNER TO BE NOTIFIED IMMEDIATELY BY CONTRACTOR OR SUB-CONTRACTOR REGARDING ANY DISCREPANCY OR OTHER QUESTION ARISING PERTAINING TO THE WORKING DRAWINGS AND/OR SPECIFICATIONS. THE CONTRACTOR SHALL BE HELD RESPONSIBLE FOR THE RESULTS OF ANY ERRORS, DISCREPANCIES OR OMISSIONS WHICH THE CONTRACTOR FAILED TO NOTIFY THE ARCHITECT/DESIGNER OF BEFORE CONSTRUCTION AND/OR FABRICATION OF THE WORK.
