California Department of Transportation, District 4: San Mateo State Route (SR) 1 Safety Barrier Project

NOTICE OF AVILABILITY of a Draft Initial Study with Proposed Mitigated Negative Declaration (IS/MND) and Virtual Open House Meeting.

WHAT'S BEING PLANNED

The California Department of Transportation (Caltrans) District 4 (Bay Area) will host a virtual open house meeting to share information on the proposed safety barrier project (project) and answer questions about what is presented in the IS/MND.

The project would take place along State Route (SR) 1, from Post Mile (PM) 36.49 to PM 38.31 north of the community of Montara in San Mateo County, California. The project would

replace all existing nonstandard metal-beam guardrail with standard Midwest Guardrail System; replace temporary concrete barriers with safety barriers; install retaining walls and safety barriers at multiple locations; and upgrade existing regulatory signs to current standards.

The purpose of the project is to enhance traffic safety by reducing run-off-theroad accidents within the project limits. From October 10, 2017, through September 30, 2020, 33 run-off-the-road accidents (including 24 injuries and one fatality) occurred on this segment of SR 1, as reported by the Caltrans Office of Traffic Safety. Accident rates within the project limits were more than 1.5 times greater than the statewide average for similar roadway facilities.

Caltrans is the California Environmental Quality Act (CEQA) lead agency and sponsor for the project and has prepared an IS/MND.
