## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION AND NOTICE OF PUBLIC HEARING

Notice is hereby given that the City of Rio Vista Planning Department has determined that the project, Oasis Farms Cannabis Facility, described below will not result in a significant adverse impact on the environment. Therefore, in accordance with the California Environmental Quality Act (CEQA), the City is preparing to adopt a Mitigated Negative Declaration (MND) as the appropriate level of environmental review. The City based this tentative determination on an initial Study that concluded the project will not result in significant environmental impacts.

Project Description: The project property occupies 3.9 acres within the City of Rio Vista. According to the City of Rio Vista General Plan (RVGP), the project site has a General Plan land use designated as Industrial/Employment Limited (I-E-L). The proposed project would require the following approvals: Conditional Use Permit; Tentative Parcel Map (TPM); Site and Architectural Approval for proposed structures; Building Permit; Adoption of a Development/Operating Agreement; and Cannabis Cultivation Licenses.

The proposed project includes construction of two, two-story 32-foot structures for indoor cannabis cultivation. Each of the four floors would include two rooms for vegetating and cloning (1,066.5 sf each/project total of 8,532 sf), 20 flowering rooms (21,330 sf per floor/project total of 85,320 sf), four drying and curing rooms (2,093.6 sf per floor/project total of 8,374.4 sf). Two irrigation rooms would be on the first floor and occupy a total of 3,600 sf. The project includes 154 parking spaces 8, of which would be Americans with Disabilities Act (ADA) compliant spaces. The entire site would be secured by an 8-foot metal fence, with driveways for emergency access.

Public Comment: The 30-day review period for the draft Mitigated Negative Declaration for the Oasis Farms Cannabis Facility project starts on February 1, 2022 and closes end of business March 3, 2022.
