The proposed maintenance activities at the Hillside Reservoir in the City of Montebello have been determined to have no potential to cause significant adverse effects on the environment and will ensure that the delivery of adequate potable water can continue to occur in an efficient and safe manner to local residents. Categorical Exemption Class 1 exempts "operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing placement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of existing or former use: (b) Existing facilities of both investor owned and publicly owned utilities used to provide electric power, natural gas, sewerage, or other public utility services." The proposed reservoir maintenance and rehabilitation activities have been determined not to have a potential to cause significant adverse environmental impacts and qualifies with the requirements of Class 1 Exemption.
