Background:

During October 2020 Alliance Investors, LLC submitted an application for a proposed tentative map and planned unit development. The proposed development site consists of approximately 18.49 acres and is currently zoned RC (Residential Condominium). The construction of single-family dwellings is a permitted use within the RC zone. An initial study and proposed mitigated negative declaration has been prepared in accordance to California Environmental Quality Act.

Discussion & Analysis:


The applicant is proposing to subdivide the 18.49 acre parcel into approximately 113 individual single family home lots and the proposed subdivision will have a dedicated park. The applicant is proposing that the single-family homes are intended to be affordable due to a high demand for moderately priced homes.

The individual lots will range in size from approximately 3240 sq. to approximately 3600 sq. ft. with some variances due to the shape of the parcel. There are individual site plans attached depicting the proposed home and outlines of the setbacks and frontages. If the tentative map and planned unit development is approved, the proposed planned unit development will have the
