Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approve two Cannabis Licenses submitted on 11/12/2020 and 03/28/2021, by Somaholistics. Somaholistics applied for a cannabis distribution and retail nonstorefront business.

Project Activities:

The proposed project will operate a cannabis retail nonstorefront and distribution operation out of an existing facility located at 1121 HOWARD ST, SAN FRANCISCO, CA 94103(-3921).

The applicant has proposed to use an existing building that is 2,700 sq.ft. Of that building 238 sq.ft. is used for the retail nonstorefront activities and 2115 sq. ft. is used for distribution activities.
