Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution License submitted on 10/18/2021, by Shawn Belschner. IE LICENSING, LLC applied for a distribution license out of an existing facility located at 31885 CORYDON ST, UNIT 130 140 150, LAKE ELSINORE, CA 92530 (APN 370-031-018). The applicant will store cannabis products for manufacturing, distribution, cultivation, and retail out of three adjoining units, totaling 5,000 square feet. Distribution will occur exclusively out of Suite 130.

Project Activities:

The Project will consist of 5,000 square feet of distribution, manufacturing, cultivation, and retail activities. The project will not expand the existing structure and there are interior modifications proposed

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building which was formerly used as a automotive repair and retail shop with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
