

# VIRTUAL PUBLIC INFORMATION MEETING NOTICE

Join OCWR staff at a public information meeting for discussion, questions and answers about the proposed Valencia Greenery composting operation.

**Background:** In response to new state legislation that mandates changes in organic waste management, OC Waste & Recycling (OCWR) is proposing to construct and operate an organic waste composting facility at the Olinda Alpha Landfill. It will be called Valencia Greenery. The Valencia Greenery composting operation would divert greenwaste that the landfill had already been receiving for use as Alternative Daily Cover (ADC) or erosion control, as well as accept other organic wastes. Instead of landfilling it, the Valencia Greenery operation will compost and distribute it for reuse at off-site locations as a soil amendment and for erosion control. The Valencia Greenery will accept up to 230 tons of material per day.

**Public Information Meeting:** OCWR invites community members to attend a virtual informational meeting to learn more about the project. Staff will be available to provide information and answer questions about the proposed Valencia Greenery composting facility and the new legislation.

**California Environmental Quality Act:** In compliance with the California Environmental Quality Act (CEQA), OCWR has prepared a Mitigated Negative Declaration (MND) for the proposed Valencia Greenery. The document is located on the OCWR website at [www.oilandfills.com](http://www.oilandfills.com). OCWR invites the public to provide any comments on the MND. At the virtual public information meeting, staff also will be available to answer questions about the CEQA process for this project and the environmental topics that are analyzed in the MND.

### PROPOSED VALENCIA GREENERY COMPOSTING OPERATION IN RESPONSE TO NEW STATE LEGISLATION

#### Frequently Asked Questions:

**Q: What is the purpose of this public information meeting?**

**A:** To inform the public about the proposed Valencia Greenery composting operation and to provide a public forum for discussion, questions and answers.

**Q: Will I notice any changes from the existing landfill operation?**

**A:** No, the proposed Valencia Greenery composting operation will not result in any noticeable changes compared to the existing landfill operation. The location of the proposed composting operation at the landfill would be more than 1.2 miles from the closest neighborhood.

**Q: What about the number of trucks to and from the landfill?**

**A:** Since most of the greenwaste that will be composted was already material that would be received at Olinda Alpha for ADC or erosion control, there would only be a limited number of new truck trips for the composting operation.

**Q: Why should I attend this meeting?**

**A:** It provides an opportunity for you to learn about the proposed Valencia Greenery composting operation and to connect with OCWR team members on any questions you might have.
