## Description of Nature, Purpose and Beneficiaries of Project:

Amendments to California Code of Regulations (CCR), Title 14, sections 165 and 165.5, and Appendix A, and the addition of new Section 705.1, will temporarily restrict commercial bull kelp harvest in Del Norte, Humboldt, Mendocino, and Sonoma counties; introduce new harvest reporting requirements; provide an option for a drying permit to meet compliance with California Fish and Game Code subdivision 6653.5(b); and make non-substantive language and structure changes throughout the regulatory text.

Starting in 2014, bull kelp populations in Mendocino and Sonoma counties have declined dramatically outside their range of normal variability due to changing oceanographic and ecological conditions. Satellite imagery data illustrates this decline has continued through the third quarter of 2021. The amendments include temporary annual harvest limits in Del Norte and Humboldt counties, a temporary harvest closure in Mendocino and Sonoma counties, and temporarily closing the three lease-only administrative kelp beds in Mendocino, Humboldt, and Del Norte counties.

The goal of the amendments is to protect and maintain the remaining bull kelp to the maximum extent possible and support ongoing restoration efforts to improve the resource in the future. The closures and limits in Sonoma through Del Norte counties would sunset in three years. The sunset date will provide time for the Department and its partners to draft and potentially adopt a kelp restoration and management plan that will provide a comprehensive management framework for giant and bull kelp.

Additionally, revisions to the kelp harvester's monthly report require separate reporting of bull kelp and giant kelp, and modifications to both the kelp harvesters' and the edible seaweed/agarweed aquatic plant harvester's monthly reports to introduce new reporting requirements of the number of individuals harvesting during the month, and central latitude/longitude coordinates for bull kelp harvest. The amendments also include weekly reporting of bull kelp harvest via email in the counties with temporary harvest limits to allow the Department to track harvest to avoid exceeding the annual quota. The regulatory changes regarding reporting requirements will provide more defined and precise reporting methods for harvesters which will provide the Department with information to make management decisions.
