### **ABSTRACT**

Tom Origer & Associates conducted a cultural resources study for the Business Center Apartments Project, near Fairfield, Solano County, California. The study was requested by Nicolas Ruhl and authorized by Jeff Morgan, both from The Spanos Corporation. This study was conducted to meet the requirements of the United States Army Corps of Engineers, Section 106 of the National Historic Preservation Act, the City of Fairfield, and those of the California Environmental Quality Act. The purpose of this report is to identify potential historical resources other than Tribal Cultural Resources, as defined in Public Resources Code [PRC] 21074 (a)(1)(A)-(B) and discussed in the Regulatory Context section). Tribal Cultural Resources are defined in Public Resources Code [PRC] 21074 (a)(1)(A)-(B) and should be identified during formal consultation between the lead agency and the tribes.

The proposed project includes the development of a 185-unit apartment complex, with a community clubhouse, pool and spa area, and outdoor amenities. Trees would be planted along the perimeter of the development. The western edge of the property would remain as undeveloped open space. The complex would be accessed from Business Center Drive via existing roads with entryways to the proposed parking area at the north and east corners of the property; an emergency access road and resident drive aisle would wrap around the perimeter of the development.

This study included archival research at the Northwest Information Center, Sonoma State University, examination of the library and files of Tom Origer & Associates, Native American contact, and field inspection of the Area of Potential Effects via pedestrian survey, and mechanically excavated trenches. P-48-000026 is plotted by the Northwest Information Center as extending into the Area of Potential Effects; however, no historic properties were found to extend into the Area of Direct Impacts.

This report contains information about the locations of archaeological sites. For the protection of these resources, this report, and such location information, should not be publicly circulated.
