Pursuant to the State of California Public Resources Code and the "Guidelines for Implementation of the California Environmental Quality Act of 1970" as amended to date, this is to advise you that the City of Laguna Beach has prepared an Initial Study for the following project.

PROJECT: Bluebird Canyon and Park Avenue Fuel Modification Projects

LOCATION/ADDRESS: Two fuel modification projects are proposed in the City of Laguna Beach and unincorporated County of Orange, California: Bluebird Canyon Fuel Modification Project and Park Avenue Fuel Modification Project. The Bluebird Canyon Fuel Modification Project includes fuel management zone (FMZ) 17 (Upper Bluebird Canyon) and FMZ 18 (South Bluebird Canyon). The Park Avenue Fuel Modification Project includes FMZ 22 (Park Avenue).

FMZ 17 begins on the south side of Temple Hills Drive east of San Remo Drive, generally follows along Temple Hills Drive to the east to Dorn Court, then south along Zell Drive and Bernard Court, and ends near Sommet Du Monde. FMZ 18 includes three areas along Bluebird Canyon Drive: (1) east of Summit Drive, (2) south of Bluebird Canyon Drive and north of Rancho Laguna Road, and (3) north of Summit Drive and La Mirada Street. FMZ 22 extends along Park Avenue, west of Hidden Valley Canyon Road, ending east of Wendt Terrace and Temple Hills Drive.

GENERAL PLAN DESIGNATION AND ZONING:

<u>General Plan</u>: FMZs 17, 18, and 22 would all traverse the following General Plan Designations: POS (Permanent Open Space), RHP (Residential/Hillside Protection), and VLD (Village Low Density). A small portion of FMZ 17 would traverse unincorporated County of Orange-designated Open Space Reserve.

Zoning: FMZ 17 traverses the following Land Use Zones: AR (Agriculture-Recreation Zone), OSC (Open Space/Conservation Zone), OSP (Open Space/Passive Zone), R1 (Residential Low Density Zone), and RHP (Residential Hillside Protection). A small portion of FMZ 17 would traverse Open Space zoned within unincorporated County of Orange. FMZ 18 traverses the following Land Use Zones: OSC (Open Space/Conservation Zone), OSP (Open Space/Passive Zone), R1 (Residential Hillside Protection). FMZ 22 traverses the following Land Use Zones: OSC (Open Space/Conservation Zone), OSP (Open Space/Passive Zone), and RHP (Residential Hillside Protection). FMZ 22 traverses the following Land Use Zones: OSC (Open Space/Conservation Zone), OSP (Open Space/Passive Zone), and RHP (Residential Hillside Protection).

PROJECT APPLICANT: Laguna Beach Fire Department, 505 Forest Avenue, Laguna Beach, CA 92651

DESCRIPTION OF PROJECT: The City of Laguna Beach Fire Department proposes to apply fuel management practices in the Bluebird Canyon area and along Park Avenue primarily within the City of Laguna Beach, California, with a small portion of FMZ 17 within unincorporated County of Orange. Fuel modification would provide defensible space adjacent to homes and a crucial evacuation route to enhance residents' ability to evacuate and allow for safer emergency access during a wildfire. All fuel modification activities would be conducted in accordance with the approved *Treatment Protocols for Fuel Modification Zones Subject to Coastal Development Permitting* (Treatment Protocols) prepared by the Laguna Beach Fire Department. Hand crews, with the option of goat-grazing, would reduce vegetation load within FMZs 17 and 18 along 100-foot-wide sections extending approximately 1.6 linear miles for a total of approximately 17.8 acres to reduce the risk of wildfire threat to residential structures. Within FMZ 22, hand crews would reduce vegetation within a 50-foot zone on either side of Park Avenue, a local evacuation road, for a total of approximately 7.2 acres. The majority of roots of perennial plants would remain, and native vegetation waste would be mulched and left on site to minimize erosion. Non-native vegetation waste would be transported to a green waste recycling facility or landfill if not recyclable. Exclusion areas within all three FMZs would be established to avoid disturbance to High and Very High Value Habitat and sensitive biological resources, such as coastal California gnatcatcher, big-leaved crownbeard, and intermediate mariposa-lily.

ENVIRONMENTAL SETTING: The overall landscape of both project areas is minimally developed at the edge of residential development and existing paved roadways, and consists primarily of chaparral and coastal sage scrub, along with populations of nonnative and invasive plant species in highly disturbed areas. FMZs 17 and 18 include High and Very High Value Habitat. FMZs 17 and 18 are located at the lower elevations of relatively steep canyon slopes, with residences at the top. FMZ 22 extends along both sides of Park Avenue, and is bounded on the east and west by residences, with predominantly open space to the north and south. FMZ 22 includes High Value Habitat. **PUBLIC COMMENT PERIOD**: From March 28, 2022 to April 29, 2022 (30 days), the public and all affected agencies are hereby invited to review the Mitigated Negative Declaration and Initial Study with mitigation measures, and submit written comments. Such comments may be submitted prior to or during the public hearing(s).

PUBLIC HEARING DATE: Wednesday, May 4, 2022 at 5:00 p.m. in City Hall Council Chambers, 505 Forest Avenue, Laguna Beach.
