Project Location: The project is located in Lytton and Castle Creeks, tributaries of the South Yuba River in the Donner Summit area of Placer and Nevada Counties, State of California; Latitude 39.31106, Longitude -120.35618, Assessor's Parcel Numbers 069-020-072-000, 047-440-022-000, 047-440-015-000, 069-020-076-000, 069-020-066-000, and 018-560-002-000, located southeast of the intersection of Donner Pass and Soda Springs Roads.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification No. NEV-30248-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, South Yuba River Citizens League, as represented by Alecia Weisman.

The project is limited to restoration of 485 acres of high elevation meadow habitat and establishment of a non-motorized trail system that circumnavigates the meadow in Placer and Nevada counties on Donner Summit at the headwaters of the Upper South Yuba River. There are four categories the proposed actions fall under: stream channel restoration, conifer treatment, road improvements, and recreation infrastructure improvements.
