
Notice of Intent to Adopt a Negative Declaration
Proposed Americans with Disabilities Act (ADA)
Improvement Project for Hopland, Mendocino County

WHAT IS BEING PLANNED

The California Department of Transportation (Caltrans) proposes to correct pedestrian facilities not compliant with the ADA, rehabilitate existing pavement, reconstruct the roadway and lower the grade on U.S. 101 to improve safety, and upgrade guardrail, drainage systems, and signage, and lighting as feasible. The project is located on U.S. 101 at post miles 10.8 through 11.2 in Hopland, Mendocino County.

WHAT IS AVAILABLE

The environmental document for this project is called an Initial Study with Proposed Negative Declaration. The document will be available by appointment for public review and copying Monday through Friday 8:00 a.m. to 5:00 p.m. from April 4, 2022 until May 4, 2022, at the Caltrans District 1 office, 1656 Union Street, Eureka, CA
