Rehabilitate the failing storm drain system and improve various athletic facilities in support of existing athletic programs at Eureka High School (1915 J Street, Eureka CA). At Albée Stadium, replace the existing track and field facilities, replace the sod football field with a new synthetic turf football field, renovate the softball field, replace stadium lighting, replace the parking lot, renovate the press box, construct ADA access improvements, demolish and reconstruct the existing field house, and construct a new multi-use building and athletics building. At Bud Cloney Field, renovate the baseball field facilities, demolish the Technology Center Building, remove the Portable Agriculture Classrooms and sheds, construct a new parking lot, and construct ADA access improvements. The existing concrete storm drainpipe that conveys Cooper Creek beneath the site will be replaced using open trenching methods with a new HP storm drainpipe that is sized to pass the 100-year storm flow, and the inlet and outlet will be improved with new concrete headwalls and rock energy dissipators. Various auxiliary, utility, and stormwater management improvements are also proposed, including the construction of new storm drain piping and bioretention basins to manage and treat stormwater runoff.
