PROJECT TITLE: Montgomery Woods State Natural Reserve Grove Trail & Visitor Experience Renovation

LOCATION: Montgomery Woods State Natural Reserve

**COUNTY:** Mendocino

**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:** California State Parks, working collaboratively with Save the Redwoods League, proposes to upgrade and reroute a hiking trail, improve parking and picnicking areas, update interpretive panels, and undertake forest restoration activities at Montgomery Woods State Natural Reserve to establish sustainable public access and long-term protection of natural resources. Project work will occur in two phases and will:

#### In Phase 1:

- Realign, restore and/or upgrade approx. 1.06 miles of the existing grove trail;
- Install four (4) boardwalks (approx. 300 ft, 175 ft, 125 ft, & 50 ft);
- Install two (2) bridges (approx. 40 ft & 60 ft);
- Install approx. 240 ft of drain lenses;
- Install approx. 150 ft of turnpike; and
- Reengineer approx. 1160 ft of the former road section of the trail.

# In Phase 2:

- Install additional parking spaces in the existing parking lot;
- Construct a retaining wall at the vehicle parking area, across the road from the parking lot;
- Add up to three (3) picnic areas;
- Construct a 450 ft connector trail between the northern and southern sections of the Grove Trail;
- Construct 100 ft of boardwalk in the gathering area;
- Develop and install new interpretive panels; and
- Complete forest restoration & forest health work by completing the following;
  - o revegetate areas denuded by visitor use;
  - $\circ\;$  thin understory vegetation and brush adjacent to trail; and
  - $\circ$  undertake pile burning of branches from tree bases and around facilities to reduce fuel loads.
