The subject parcel is located on the south side of E. Jensen Ave., 190 feet east of S Maple Ave., 876 feet west of S Sierra Vista Ave., southernly adjacent of the nearest city limits of the City of Fresno (APNs: 487-070-45 & 46) (4646 E Jensen Ave.) (Sup. Dist. 3).

California Native American Tribes did not enter into consultation with the County on the project and no concerns were expressed with the project.
