The subject property is generally on the east side of McCall Avenue between Bullard Avenue and Herndon Avenue, approximately 1.25 miles northeast of the nearest city limits of the City of Clovis. (SUP. DIST. 5) (APNs 308-231-01S and 308-231-02S).

Participating California Native American tribes were notified of the subject application under the provisions of Assembly Bill 52 (AB 52) and were given the opportunity to enter into consultation with the County. No participating California Native American tribe expressed concerns with the application to indicate the presence of cultural resources.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation.
