Project Location (include county): The project to be completed is located within the South Fork Salmon Creek watershed, approximately 3.75 miles southwest of the town of Miranda, County of Humboldt, State of California. The project is located in Section 18, T3S, R3E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 219-041-008; latitude 40.201246 N and longitude 123.880512 W at the parcel center.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-24448-R1, pursuant to Section 1602 of the Fish and Game Code to Corynne Kovacs.

The project is limited to 4 encroachments on unnamed tributaries to South Fork Salmon Creek. Three encroachments are to upgrade existing culverts (2 stream crossings and 1 pond spillway). Work for these encroachments will include excavation, culvert removal, culvert replacement, backfilling and compaction of fill, and rock armoring as necessary to prevent erosion. The other encroachment is for water diversion for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure in compliance with the measures of the Agreement.
