Statutory Authority: California Health and Safety Code, Chapter 6.5

**Project Description**: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.61, has issued an Emergency Permit to the US Geological Survey, (EPA ID# CA2470090364) to treat hazardous waste through a controlled reaction with a chemical solution. Specifically, four (4) containers of Ethyl Ether (4 x 1 Liter), must be stabilized prior to transport to an authorized hazardous waste treatment, storage, and disposal facility.

These chemicals are currently being stored at US Geological Survey located at 345 Middlefield Road, Menlo Park, California. DTSC has determined as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous waste prior to storage and eventual transportation off-site by Clean Harbors Environmental Services (Clean Harbors).

**Background**: Peroxide forming materials may spontaneously decompose and become explosive with or without external energy. Some peroxides may explode without being concentrated. If the material is improperly handled, there is a potential for a reaction, which includes fire, deflagration, or detonation. This makes transport of these waste chemicals hazardous. Chemical stabilization is recommended prior to transport to a permitted treatment, storage, and disposal facility.

**<u>Project Activities</u>**: The treatment of the hazardous waste involves the addition of solution to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemical.

Treatment will take place within a designated exclusion zone. Only technicians from Clean Harbors will be allowed in the exclusion zone. Movement, preparation, and treatment of the containers will be in accordance with established standards.

Within 10 business days of the expiration of this permit, US Geological Survey will submit a final report, signed in accordance with Title 22, California Code of Regulations section 66270.11(d). The report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed.

The Emergency Permit is effective beginning April 29, 2022 and shall expire on June 27, 2022.

Chemical stabilization of the chemicals is necessary prior to transportation to an authorized hazardous waste treatment, storage, and disposal facility to prevent accidental fire and/or explosion during transport.
