Project Location: The Project is located at 3100 DEL MONTE BLVD, MARINA, CA 93933(-3049), in Monterey County

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 6/21/2021, by Pacific Roots Marina LLC. The Pacific Roots Marina LLC applied for a Cannabis retail dispensary.

Project Activities:

The proposed project will operate a cannabis retail dispensary out of an existing facility located at 3100 DEL MONTE BLVD, MARINA, CA 93933(-3049) (APN 032-192-018).

The applicant has proposed to use 1,977 sq. foot of a 2,922 sq. ft. building to operate a cannabis retail dispensary. The facility's retail area would be 714 sq. ft. in size, the remainder of the facility would be utilized for ancillary purposes including storage space, office space, and two restrooms.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
