**Project Title:** TDRPD 3 Piers Replacement (Lake and Streambed Alteration Agreement EPIMS Notification No. NEV-25269-R2)

**Project Location:** The project is located at Donner Lake, in the County of Nevada, State of California; at three locations (WGS 84 datum, decimal degrees): Pier 15: Latitude 39.325029, Longitude -120.271811, Pier 21: Latitude 39.325980, Longitude -120.267782, Pier 29: Latitude 39.327797, Longitude -120.260617

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement EPIMS Notification Number NEV-25269-R2, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, Truckee Donner Recreation and Parks District, as represented by John Shaffer.

The project is limited to the removal and replacement of three piers on Donner Lake. The piers are identified as pier 15, pier 21, and pier 29. The dilapidated piers will be replaced in approximately the same footprints. The work will be conducted during low water conditions and Best Management Practices (BMP) will be implemented to prevent water quality impacts.

The project sites will be accessed using an amphibious vehicle. The amphibious vehicle will also be used to transport materials and drive the piles. A 6-foot, by 6-foot steel landing mat will be used for any soil deformation greater than 3-inches deep, to protect water quality and prevent pumping of excess soil moisture.

Piers 21 and 29 will have a 3-foot, by 6-foot, by 3-foot concrete foundation to anchor the new piers to the upland shoreline. Pier 15 will have 3-foot, by 4.5-foot, by 3-foot foundation. The piers consist of a 6-foot width design, steel joists and girders, Trex decking and fascia, 10 ¾-inch diameter steel piles, concrete landings not to exceed 90-cubic-feet, and side-mounted access ladders. Pier 15 will be 36-feet long, 6-feet wide and will had a 10-foot ramp. Pier 21 will be 38-feet long and 6-feet wide. Pier 29 will be 50-feet long and 6-feet wide.
