# NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION MONTEREY COUNTY PLANNING COMMISSION

NOTICE IS HEREBY GIVEN that Monterey County Housing & Community Development (HCD) has prepared a draft Mitigated Negative Declaration, pursuant to the requirements of the California Environmental Quality Act (CEQA), for a Combined Development Permit (Love, File Number PLN210007) at 30560 Aurora Del Mar, Carmel, Big Sur Coast Land Use Plan, Coastal Zone (Assessor's Parcel Number 243-331-003-000) (see project description below).

The Monterey County Planning Commission will consider this proposal at a public hearing on a future date to be determined, in the Monterey County Board of Supervisors Chambers, 168 West Alisal, 2<sup>nd</sup> Floor, Salinas, California. Written comments on this Mitigated Negative Declaration will be accepted from May 9, 2022 to June 8, 2022. Comments can also be made during the public hearing.

**Project Description:** Combined Development Permit consisting of a Coastal Administrative Permit and Design Approval to allow the construction of a 5,067 square foot two-story single-family dwelling with a 782 square foot attached garage; a Coastal Administrative Permit and Design Approval to allow construction of a 425 square foot detached guesthouse; a Coastal Development Permit to allow development within 750 feet of known archaeological resources; a Coastal Development Permit to allow development within 100 feet of an environmentally sensitive habitat area; a Coastal Development Permit to allow development on slopes exceeding 30 percent; and a Coastal Development Permit to allow development within 50 feet of a coastal bluff.
