Project Description

The California Department of Transportation (Caltrans) proposes installing wayfinding and interpretive signage along Ebbetts Pass National Scenic Byway. The project will occur on State Route (SR) 4 from post mile (PM) 41.92 to 65.87 in Calaveras County, on SR-4 from PM 0.00 to 31.68 in Alpine County, and on SR-89 from PM 9.96 to 15.30 in Alpine County. The scope of work includes installing confidence markers and other related signs on new or existing signposts. Three gateway monuments will be installed at the western and eastern entrances to Ebbetts Pass. All work will occur within existing Caltrans Right of Way. The purpose of this project is to provide a better navigational and interpretive experience for locals and visitors traveling on Ebbetts Pass. The project is needed to restore a sense of pride in these rural communities and to facilitate visitor understanding, appreciation, and advocacy of the surrounding resources.

General:

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.
- Contact the Environmental Office to attend the pre-construction meeting.

Cultural:

- If cultural materials are discovered at the job site, do not disturb the resources and immediately:
 1. Stop all work within a 60foot radius of discovery
 2. Protect the discovery area
 3. Notify the Engineer
 4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste:

- The Caltrans Standard Special Provision, 7-1.02K(6)(j)(iii), which pertains to Earth Material Containing Lead, shall be added to the construction contract. A lead compliance plan prepared by a Certified Industrial Hygienist (CIH) is required.
- If the disposal of Treated Wood Waste is required, Caltrans Standard Special Provision (SSP) 14-11.14 regarding the handling, storing, transporting, and disposing of treated wood waste shall be included in the construction contract.

Biology:

- There are Environmentally Sensitive Areas (ESA) within the project limits. If ground disturbance occurs within 20 feet of any water resource, clearance from the District 10 Environmental Office is required prior to the start of any

construction related activities. No construction related activities are allowed within the following ESAs:

- CAL/4/43.7/44.3 near Big Tree Creek
- CAL/4/R47.6/49.2 near San Antonio Creek
- CAL/4/R60.3/R62.3 near Big Meadow Creek
- ALP/4/R0.7/R1.9 near Blood Creek
- ALP/4/R3.6/R4.7 near Lake Alpine
- ALP/4/9.3/12.9 near water resources such as North Fork Stanislaus River, Mosquito Lake, and Pacific Creek
- ALP/4/17.5/29.2 near an area sensitive for species of special concern
