The proposed project involves the installation of a one-megawatt (MW) solar array with single-axis tracking system, including 1.1 MW of direct current photovoltaic (PV) modules, steel support structures, a one-MW alternating current electrical inverter, cabling, and other system components. The project also includes a main service board and a step-up transformer as well as metering facilities, conductors, and safety equipment for interconnection to Pacific Gas and Electric's (PG&E) distribution system via a new primary meter installed within the project site. The electricity generated by the proposed project would offset JID's aggregated electricity usage for the canal and well pumps across JID-owned parcels. The solar power generated on the project site would offset JID's aggregated electricity usage for the canal and well pumps across JID-owned parcels. The solar power generated on the project site would be used to generate bill credits for JID's meters in the Renewable Energy Self-Generation Bill Credit Transfer Program (RES-BCT) arrangement to offset their PG&E energy generation charges. The project's interconnection with PG&E would require minor off-site construction to connect the proposed solar array to an existing PG&E generation tie line located immediately south of the project site.
