



# Do you want a virtual public meeting on changes proposed for State Route 12 in Calaveras County?



#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to improve the intersection at State Route 12 (from post miles 9.9 to 10.3) and the entrance/exit of the Valley Oaks Shopping Center in Calaveras County. The project proposes to reduce the number and severity of broadside collisions at this location through intersection control improvements. The project would require additional right-of-way and utility relocation. Project work may include frontage roads, turn lanes, sidewalks, bus stops, bike lanes, and curb ramps.

### WHY THIS PUBLIC NOTICE?


# Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly

affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for you to read and comment on. This notice also offers you an opportunity to request a virtual public meeting.
