## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 8217 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

**INITIAL STUDY APPLICATION NO. 8217** and **UNCLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3740** filed by **Kevin Gallagher** proposing to allow for the installation of a new unmanned telecommunications facility in a 40' x 40' AT&T lease area that includes a 145' tall lattice tower and an 8' x 8' walk in closet and an emergency back generator in the AE-40 (Exclusive Agricultural, 40-acre minimum parcel size) Zone District. Adopt the Mitigated Negative Declaration prepared for Initial Study Application No. 8217 and act on Unclassified Conditional Use Permit No. 3740 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 8217 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.
