Install DIP/PVC coupling between the replaced and existing pipeline segments.
		Construction of approximately 605 feet of 8- inch diameter CMC/CML water pipeline in an easement to be obtained in Dalley Way (private road) that will connect to an existing




Figure 1 - Vicinity Map and Project Location
