LOCATION: Adelanto, California 92301. The corresponding Assessor Parcel Number (APN) is 3210-631-012 & 013. The proposed project site is located on the southwest

corner of Rancho Road and Koala Road in the southwestern portion of the City.

PROJECT DESCRIPTION:The City of Adelanto is reviewing an application to develop a 6.05-acre (263,730 square-foot) site within the southcentral portion of the City of Adelanto. The proposed project involves the construction of eight (8), two-story buildings that

would be used for cannabis cultivation, distribution, and manufacturing. The total floor area of the new buildings would be 214,608 square-feet. In addition, 185 standard parking spaces and 16 ADA compliant stalls would be provided. Vehicular access to the proposed development would be provided by driveway connections with the future Violet Road (on the north) and Koala Road (on the

east). The property has a General Plan and Zoning land use designation of

Manufacturing/Industrial (MI)

ENVIRONMENTALINFORMATION:
The environmental analysis provided in the attached Initial Study indicates that the proposed project will not result in any significant adverse unmitigable

impacts. For this reason, the City of Adelanto determined that a *Mitigated Negative Declaration* is the appropriate CEQA document for the proposed

project.

FINDINGS: The proposed project will not have the potential to substantially degrade the

quality of the environment, substantially reduce the habitat of a fish or wildlife species, cause a fish or wildlife population to drop below self-sustaining levels, threaten to eliminate a plant or animal community, substantially reduce the number, or restrict the range of a rare or endangered plant or animal or eliminate important examples of the major periods of California history or prehistory The proposed project *will not* have impacts that are individually limited, but cumulatively considerable. The proposed project *will not* have environmental effects which will cause substantial adverse effects on human

beings, either directly or indirectly.




Figure 1: Citywide Map




Figure 2: Project Site Location
