

NOTICE OF AVAILABILITY AND INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION FOR THE 400 EAST MILLBRAE OUTDOOR ADVERTISING DISPLAY SIGN PROJECT

Friday, June 24, 2022

Notice is hereby given that the City of Millbrae (City), as the lead agency under the California Environmental Quality Act (CEQA), has prepared an Initial Study/Mitigated Negative Declaration ("IS/MND") for the 400 East Millbrae Outdoor Advertising Display Sign Project ("Project"). The project applicant is Outfront Media Incorporated. The IS/MND is now available for public review and comment.

Physical copies of all documents incorporated by reference in the MND are available for review at the Planning Division office located at 621 Magnolia Avenue, Millbrae.

Environmental Review: To ensure the proposed project is fully analyzed under CEQA, a Draft IS/MND was prepared in compliance with CEQA and the CEQA Guidelines to determine the appropriate scope and level of detail required in completing the environmental analysis for the proposed project. The initial study identified potentially significant effects, but revisions agreed to by the applicant determined that the project would avoid or mitigate the effects to a point where clearly no significant effects would occur, and there is not substantial evidence, in light of the whole record before the agency, that the project as revised may have a significant effect on the environment (CEQA, Article 6. Negative Declaration Process, Section 15070 (a) and (b)). The City has reviewed and considered the proposed project and has determined that the project will not have a significant effect on the environment, with substantial supporting evidence provided in the Initial Study. The City hereby prepares and proposed to adopt a Mitigated Negative Declaration for this project.

Project Location: The project is located at 400 East Millbrae Avenue, bounded by US-101 to the west, Millbrae Avenue to the south, US-101 northbound on-ramp and South McDonnell Road to the north, and a surface level parking lot to the east. The 2.39-acre parcel is located at 400 East Millbrae Avenue (APN #024-371-010) within the City General Plan's Millbrae Station Area Specific Plan designation and Public Facility zone. The project site is located on a city owned parcel that is developed with the City's Water Pollution Control Plant (WPCP). Surrounding land uses include SFO located approximately 0.1 mile north of the projects site. San Francisco Bay is located approximately 0.1 mile east of the site and the Millbrae Bay Area Rapid Transit (BART) and Caltrain Station (Millbrae BART/Caltrain Station) is located approximately 0.3 mile west of the project site.

Project Description: The applicant proposes to construct a double-sided Outdoor Advertising Display Sign (OADS) at 400 East Millbrae Avenue. The OADS will consist of two back-to back light-emitting diode (LED) digital displays and the sign structure. These displays would be north- and south-facing that would be visible to vehicles traveling in both direction on U.S. Highway 101 (US-101) (northbound and southbound). Both billboard panels would be LED digital display panels used for general commercial advertising.
