**PROJECT TITLE:** Mineral Bar Temporary Kiosk

LOCATION: Auburn State Recreation Area COUNTY: Placer

**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT**: Install a temporary kiosk, grade the park road, and create two staff parking spaces at Mineral Bar Campground within Auburn State Recreation Area to accommodate increased visitation, improve recreational opportunities, and improve accessibility. Work will use heavy equipment and hand tools to:

- Remove one (1) Redbud tree;
- Bring in up to 35 cubic yards of fill to level the ground and cover the fill slope with river rock backing;
- Excavate to pour an 18 foot by 18 foot by 6 inch thick concrete slab to install a prefabricated 8 foot by 8 foot kiosk;
- Remove the existing asphalt park road at the entrance, grade and pour new asphalt to meet ADA standards; and
- Place approximately 60 yards of aggregated base to establish two (2) parking spaces for staff that meet ADA standards.
